This case was tried before a jury on July 21, 1988, on the issue of whether the Plaintiff Cincinnati Metropolitan Housing Authority had good cause to evict the Defendant Connie Foster. Upon consideration of all the evidence, the jury found by a preponderance of the evidence that good cause existed to terminate the tenancy of the Defendant and that the Defendant's failure to pay rent was not a result of circumstances beyond her control. With regard to the Defendant's equity defense, the Court, after consideration of all the evidence and the review of the Memoranda submitted by counsel, finds that the Defendant Connie Foster is not entitled to an exercise of its equitable jurisdiction, except to the extention to court will exercise power to the effects of the of the court will exercise the effects.

If the Defendant fails to vacate the premises on or before December 1, 1988, or fails to make a rental payment as provided, a Writ of Restitution shall issue forthwith.

With respect to Plaintiff CMHA's Second Cause of Action, judgment is entered in favor of the Plaintiff Cincinnati Metropolitan Housing Authority and against the Defendant Connie Foster in the amount of \$660.75. All monies paid into the Court by Connie Foster as bond shall be released to the Plaintiff forthwith.
