Working Mom Gets Help

Legal Aid helps a family access benefits to get back on their feet.

On game day at FirstEnergy Stadium, when fans are roaring and the Dawg Pound is barking, Tamika Jefferson enjoyed the atmosphere as a member of the stadium's security department. But last season, in the middle of a difficult pregnancy, her doctor ordered her to stay home.

Without her job, the single mom of four soon fell behind in her rent. After being denied an extension of short term benefits, Ms. Jefferson was scared. She told her doctor at MetroHealth's Broadway Health Center she needed help.

The MetroHealth social worker, Tangela Woods, referred Ms. Jefferson to Legal Aid's Community Advocacy Program on-site at MetroHealth. Through this program, medical providers and Legal Aid work together to resolve legal issues that are barriers to health for low-income patients. Legal Aid attorney Shelly Anarado Okere has regular office hours at the clinic, so help was just down the hall.

Ms. Woods has seen many cases like Ms. Jefferson's where vulnerable people aren't aware of their rights. "With a letter from an attorney, they feel empowered and supported in the challenges they are facing," she says. "Transportation is a big barrier for our patients, so a one-stop shop really works for them. They can see the doctor, the attorney and me all in one visit."

Ohio Works First should provide short-term cash assistance to people in Ms. Jefferson's situation. When Ms. Okere looked at Ms. Jefferson's paperwork, she recognized that the agency wasn't applying the proper eligibility criteria. The county requires a "pending eviction," but Ms. Jefferson's housing situation was precarious; there was no pending eviction. Her landlord indicated that he didn't want to put a family out on the street, but that his patience had a limit.

Thanks to Legal Aid, Ms. Jefferson was able to enroll in MomsFirst, a life skills training course,

and got 6 months of cash assistance to help her with living costs. Ms. Jefferson says she is grateful not only for the successful outcome, but for the relief of having her attorney's support.

"Shelly told me I was doing everything I'm supposed to be doing and to let her take it from there. She told me everything's gonna be fine," said Ms. Jefferson. Her Legal Aid lawyer went to all the meetings and kept in touch to let her know how things were progressing.

Baby Demetrius was born in early June – five weeks premature – and spent his first two weeks in the hospital. In addition to caring for her newborn, Ms. Jefferson looks forward to going back to work. Ms. Jefferson is eligible to reapply for extended benefits – but she won't. She states, "I have to provide for my kids."

Board Member Profile: Vanetta Jamison

Vanetta Jamison was proud to join The Legal Aid Society’s board of directors in 2011. Ms. Jamison had been an entrepreneur and active member of her community for a decade prior to joining Legal Aid. She was always drawn to helping families and children and Legal Aid was the perfect place for her to nurture her passions.

Ms. Jamison knew first-hand the impact Legal Aid can have on a family: she was a family law client in 2004. Her connection to the organization was solidified through the intense encouragement and dedication of her attorney, Susan Stauffer. Ms.

Stauffer is a Senior Attorney at Legal Aid and describes Ms. Jamison as a “fabulously determined woman and so dedicated to her kids,” from day one of her representation. Ms. Jamison’s divorce was granted and soon after, she graduated from college with a degree in business administration. Ms. Jamison now works with The United States Department of Veterans Affairs. There she is able to work with a client base similar to that of Legal Aid while remaining an active board member, frequently attending neighborhood brief advice clinics.

Ms. Jamison brings her unique experience and determination to Legal Aid’s board of directors. She says she never hesitates to refer people to Legal Aid when they’re in need of information or services, noting that the most important thing Legal Aid gave her was “a support group; people who understand what you’re going through and how you feel.”

Two New Fellows Serve Legal Aid Clients

Legal Aid is proud to host both an Equal Justice Works Fellow and an Equal Justice Works AmeriCorps Fellow. Both programs help young lawyers pursue careers in public interest law.



Danielle Gadomski Littleton, Esq.

Danielle Gadomski Littleton is Legal Aid's Equal Justice Works Fellow focusing on legal issues of youth in foster care and young adults aging out of the system. She works closely with the various county family services departments, and other partner agencies for foster youth.

"Youth in foster care have undergone a lot of trauma in their birth homes or as a result of their removal and that can trigger mental health issues," says Ms. Gadomski Littleton, noting that the rate of post-traumatic stress

disorder is higher for children in foster care than for combat veterans.

She trains families and social workers to recognize potential legal issues, for example, access to appropriate education. "A teacher might see a child acting out, but that impulsive behavior may be related to their situation. The school may recommend discipline or expulsion, when the youngster really should be getting support services so they can stay in school and graduate." She may advise or represent the young person to get the school district to provide appropriate services.

At Denison University, the Columbus native understood that not everyone grew up with the advantages and family support she had and that pushed her to be more proactive. While deciding between a graduate degree in social work or law, she was an AmeriCorps volunteer at an agency for children in foster care. She observed that judges looked to attorneys as the authorities on the cases. A public interest scholarship funded her law degree from Ohio State University's Moritz College of Law with a Certificate in Children's Studies.

"I fell in love with this issue because I saw the impact one person could have" as a child advocate, she says. "I wanted to work with Cleveland Legal Aid because it is a strong program and I knew I would get great training and exposure to lots of issues."

Jami Altum-McNair is serving the civil legal needs of low-income veterans as Legal Aid's Equal Justice Works AmeriCorps Fellow.

"For some vets, something happens in the service that makes it difficult to adjust to civilian life," she says. "That can start a domino-effect of problems - their marriage falls apart, then they can't pay their child support payments, so they lose their driver's license and then they can't work. Some veterans may end up homeless or with substance abuse problems, or both."

"There are many veterans' service organizations in Cleveland, but none of them do legal work. Sometimes veterans need someone who can go to court for them," she says.

In addition to representing clients, Ms. Altum-McNair also increased access to legal services for veterans by holding brief advice clinics twice a month at a VA facility, one in conjunction with volunteer lawyers from McDonald Hopkins and Legal Aid's Volunteer Lawyers Program staff. Vets can bring in legal paperwork they don't understand, talk to an attorney and learn what the documents mean and what to do.

The daughter of a veteran, Ms. Altum-McNair served in the Army as a licensed practical nurse stationed at Fort Campbell, KY and was deployed to Kosovo. She became the first person in her family to attend college, graduating summa cum laude from Wright State; then attended law school at Case Western Reserve University and graduated *cum laude*, concurrently earning a MA in Bioethics.

Ms. Altum-McNair adds: "I had a family support network to help me when I left the service. Now I want to be that help for others. We moved to Cleveland so our son could go to the same schools as my husband, Cuyahoga County prosecutor Ben McNair, so when I found this opportunity to serve low-income veterans in my adopted hometown, I couldn't have been more excited."

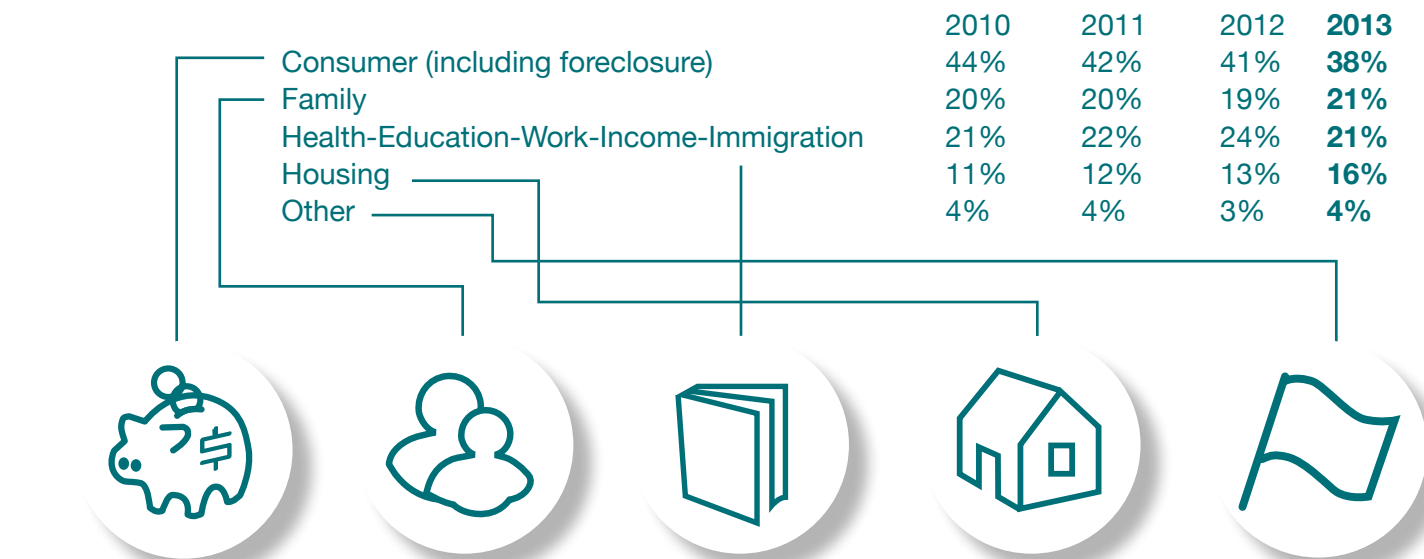

- Men: 31%

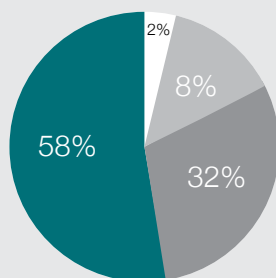


Focus on Special Populations:
