# A U.S. Veteran Restarts Her Life After Resolving a Debt.

## Legal Aid helps client resolve consumer law issue

Linda Green was a college graduate, published author and poet, and had risen to the ranks of captain in the U.S. Army when her life changed The forever. birth of her child left her disabled. She was forced to leave the military, and she struggled for depression. Like most college graduates, Green also had student loan debt

which was deferred due to her disability status. However, just weeks before a life-changing surgery (following more than a half-dozen surgeries since her military discharge) Green was informed that her disability benefits, her sole source of income, would be garnished by 20% for student loan repayments. Besides major surgery to reconstruct her abdominal wall and notice of garnishment by the department of education, Green was in the midst of a battle with Veteran Services regarding her disability status. Unsure of how she was going to financially survive if her disability was garnished, Green came to Legal Aid for help.

"The Legal Aid attorney was really excited to help with my situation...it took a lot of pressure off me," said Green. Over the next month, Ms. Green's disability checks were no longer garnished. No more money was withdrawn from her disability accounts. And, a few weeks later, she received a letter from the U.S. Department of Education informing her that her student loan debt was discharged.

"I would have never considered reaching out to Legal Aid if they didn't have the clinic for U.S. Veterans. I thought I was just going to have to sit back and pray I don't get taken advantage of," said Green. "Working with Legal Aid made this process so much easier; I don't think I would have been able to do this by myself. The Legal Aid attorneys

validated my own assessment of my situation. They were so prepared and willing to help that it made all the difference in actually making this happen." Green is now student loan debt-free and has one less worry on her road to recovery. Legal Aid empowers clients like Ms. Green to continue to advocate for positive results in their own



# "Working with Legal Aid made this process so much easier ..."

"Overwhelmed was an understatement," said Green. However, she knew this issue could not wait. Two weeks after the surgery, while still recuperating, Green came to a Legal Aid clinic hosted in partnership with the Veterans Administration's Community Resource and Referral Center on Euclid Avenue in Cleveland.

## **LEGAL AID'S MEDICAL-LEGAL** PARTNERSHIP ENSURES STABILITY **FOR FAMILY**

Legal Aid partners with MetroHealth Medical Center through the Community Advocacy Program (CAP), providing on-site legal services to lowincome individuals seeking medical treatment. The Legal Aid and MetroHealth partnership, now in its tenth year, ensures healthy communities are developed beyond the medical examining room. Susan Warner was referred to Legal Aid through CAP after failing to obtain disability benefits for her 5-year-old daughter, Ashley. Ashley was very successful academically in her kindergarten class, but then had a debilitating seizure that caused significant development delays. She repeated kindergarten twice and attends school with a nurse because of her medical condition. With Legal Aid's assistance, Ms. Warner received a back payment of disability benefits and regular monthly SSI benefits. Ashley's epilepsy is controlled through medication and the additional government benefits will allow for additional assistance for continued success including regular counseling and speech therapy.



# A BRIGHTER FUTURE WITH A **BETTER EDUCATION**

Maintaining and preserving access to education is important to Legal Aid's practice. Education empowers individuals with the hope of breaking the vicious cycles of poverty. Children with special needs face additional barriers to education as they must show their needs require special accommodations for the best education possible.

Kim Parker, a frustrated mother to an adopted 5-year-old boy, came to Legal Aid when her son's school refused to address his disability, despite psychiatric opinions that he needed special services. The school refused to acknowledge his needs and expelled him for "behavioral problems." Legal Aid attorneys worked diligently to get Parker's son back in school with the services he needed. Parker's son now attends a Positive Education Program school and mother and son are both happy with their new circumstances.
