PURSUANT TO R.C. SECTION 2506.02, "WITHIN FORTY DAYS AFTER FILING A NOTICE OF APPEAL . . . [THE] BODY FROM WHICH THE APPEAL IS TAKEN, UPON THE FILING OF A PRAECIPE BY THE APPELLANT, SHALL PREPARE AND FILE IN THE COURT TO WHICH THE APPEAL IS TAKEN, A COMPLETE TRANSCRIPT."

A REVIEW OF THE DOCKET SHOWS THAT THE APPEAL AND PRAECIPE WERE FILED ON 02/15/2017. ACCORDINGLY, APPELLEE WAS REQUIRED TO FILE THE CERTIFIED RECORD BY 03/27/2017. APPELLEE FILED THE CERTIFIED RECORD ON 04/17/2017, THREE WEEKS LATE.

UPON A SHOWING BY APPELLEE OF ITS EFFORTS TO COMPLY WITH AND INABILITY TO MEET THE DEADLINE, THE COURT MAY GRANT APPELLEE AN ADDITIONAL 30 DAYS TO COMPLY. HERE, APPELLEE MADE NO SUCH SHOWING TO THE COURT, BUT MERELY UNTIMELY FILED THE CERTIFIED RECORD. BECAUSE APPELLEE HAS FAILED TO FOLLOW THE STATUTORILY MANDATED PROCEDURE, THIS COURT MUST ENTER JUDGMENT IN APPELLANT'S FAVOR. THE DECISION OF APPELLEE CUYAHOGA METROPOLITAN HOUSING AUTHORITY IS REVERSED. COSTS TO APPELLEE.
