Executive Director's Note

As Dr. Martin Luther King, Jr. said, “*The arc of the moral universe is long, but it bends toward justice.*” In that speech, Dr. King reminded us that the arc doesn’t bend on its own. The arc is one that we shape, that we direct, that we pull and push and guide toward justice. It is our work, our words, and our actions that better our moral universe.

Recognizing this call to action, Legal Aid continues striving to be a beacon for justice. Together with our clients, dedicated volunteers, generous supporters, and strong community partnerships, we protect the rights of our neighbors and advocate for solutions to the problems of poverty, racism, and inequality. I am excited to share a few of our many accomplishments from this past year.

We achieved incredible victories alongside people like Derek (*alias for privacy*), a veteran who moved to the greater Cleveland area shortly before the onset of the COVID-19 pandemic. Despite securing a job and place to live, Derek soon found himself facing hard times. His workplace closed, leaving him unemployed and unable to pay his rent. He took initiative, found a new job, and applied for rental assistance. Even after his best efforts, Derek still had a significant outstanding balance on his rent payments. As a result, his landlord filed to evict him.

With nowhere else to turn, Derek discovered Legal Aid. A Legal Aid attorney negotiated with Derek’s landlord and came to an agreement in which Derek would not be evicted if the rent assistance he applied for came through. However, the landlord allegedly did not receive the rent assistance in time, so he moved forward with the eviction. As it turned out, though, Derek’s rent assistance was deposited with his landlord, so his attorney acted quickly to correct this misunderstanding. With proof that the rent assistance was deposited, the landlord dropped the eviction and Derek was able to stay in his home.

In 2022, Legal Aid helped **over 21,000 people** like Derek through **nearly 8,000 cases**. We are proud to have accompanied so many people on paths of strength, stability, and hope.

Legal Aid’s efforts impacted thousands more people through our community outreach, education, and advocacy work. In the last year, Legal Aid advocated for expanded Right to Counsel legislation that would prevent more evictions, address poor housing conditions, and respond to an eviction crisis that disproportionately impacts Black and female led households. We also advocated for solutions that reduce the burden of debt-related license suspensions, which create significant barriers to employment - especially for low-paid workers. Through these initiatives and many more, Legal Aid is promoting systemic changes that make it easier for everyone in our community to thrive.

We are grateful to all our supporters who helped make this impactful work possible in 2022. Your continued partnership fuels our ongoing efforts to help individuals, families, and communities overcome barriers to opportunity. The journey might be long, but together, we can bend the arc and extend justice in Northeast Ohio!

Together We Can create community change

Published in September 2022, the research report, "Road to Nowhere: Debt Related Driver's License Suspensions in Ohio" is part of Legal Aid's ongoing work to address barriers to transportation for low-income communities.



Approximately **60%** of all Ohio driver's **license suspensions** are based on a person's failure to pay a fee or fine.

Debt-related license suspensions penalize those with limited means, resulting in a vicious cycle of poverty and criminalization.

VOLUNTEERS PLAY AN IMPORTANT ROLE IN HELPING LEGAL AID CLOSE THE JUSTICE GAP.

Annually, up to 20% of Legal Aid's matters are handled by *pro bono* attorneys.

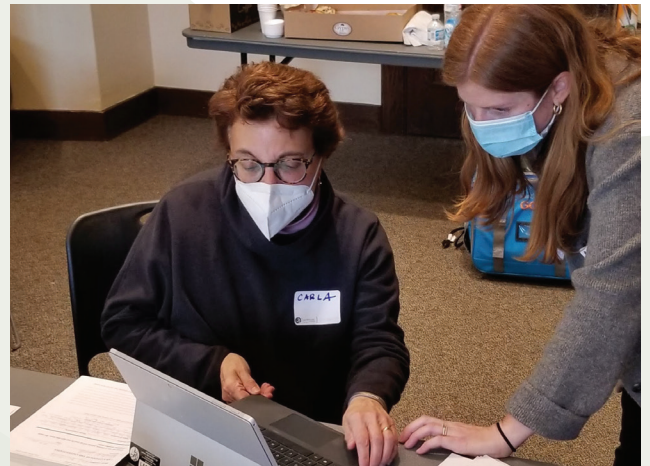

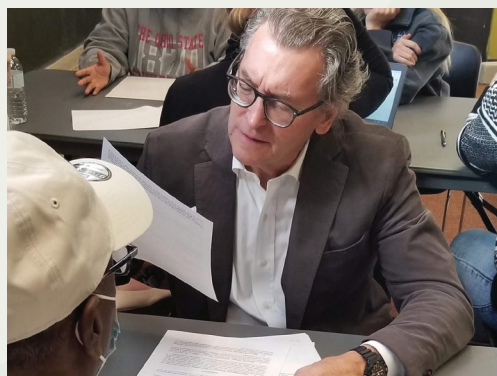
