Eligibility for Legal Aid Services

1. Applicants from Legal Aid service areas (Ashtabula, Cuyahoga, Geauga, Lake, Lorain)
2. With income up to 200% FPL (some exceptions)
3. Facing civil legal problems

Problems Legal Aid Helps Resolve

CHILD & FAMILY



- Divorce and custody
- Domestic violence protection orders
- Estate planning
- Immigration
- Special education
- School discipline and expulsion

HEALTH CARE



- Medicaid and Medicare (*denials, reductions or terminations in coverage*)
- Medical bill collection
- Marketplace tax credits and penalties
- Access to medical records

HOUSING



- Eviction defense
- Foreclosure defense
- Landlord retaliation lock-outs, utility shut-offs
- Public and subsidized housing (*evictions, terminations and some denials*)
- Utility issues (*medical certifications or tampering allegations*)

MONEY



- Bankruptcy (*if debts impact wages, utility service, driver's license or home sale*)
- Public benefits, such as food stamps, cash assistance, supplemental security income, energy assistance
- Student loans, payday loans, auto title loans, and debt collection lawsuits

WORK



- Sealing criminal records
- Income tax problems with the IRS
- Obtaining valid ID and professional license
- Unemployment Compensation appeals

Legal Aid cannot help with criminal matters or applications for benefits.

What to Expect When Applying

Be prepared to provide income and asset information.

Have information and any papers related to your legal problem with you.

Sign and return papers that Legal Aid sends you right away.

Legal Aid offers representation, advice, self-help assistance, information, or referrals whenever possible.

Sometimes Legal Aid has to turn potential clients away due to a lack of resources.
