This matter came on for pretrial and change of plea, this 18th day of May, 2004, the State of Ohio represented by the Prosecuting Attorney, Clifford N. Sickler, and the Defendant appearing in open court with retained counsel, Attorney Mark Morrison.

The State moved to amend the felony theft charge contained in Count 2 to a violation of § 2913.02 of the Ohio Revised Code, a misdemeanor of the first degree. The State moved to dismiss Count 1 charging burglary and the Court accepted the amendment and dismissal without objection.


Whereupon the Court inquired of the Defendant as to her plea to the charge as amended, and the Defendant pled no contest. The Defendant waived the presentation of evidence sufficient to sustain a conviction beyond a reasonable doubt. The Court found the Defendant guilty.

Whereupon the Court proceeded to sentencing and sentenced the Defendant to a term of 90 days in the Noble County Jail; \$500.00 restitution; \$500 fine; court costs; the sentence suspended upon the successful completion of a two year non-reporting probationary period with standard terms and conditions of probation with no violations of law other than minor misdemeanor traffic offenses.
